## COUNSELING AS A PROFESSION

The United Nations Office of Drug Control estimates that "205 million people in the world use illicit drugs, of whom some 25 million are drug dependent. For \$US 1 invested in evidence-based treatment, up to \$US 6 are saved in terms of costs for health, security and welfare."

Beyond drugs, the International Society for Addiction Medicine now defines addiction as a brain disease, regardless of substance or frequency.

A thorough understanding of the mechanisms of addiction and the latest evidence-based practices for treating it is the hallmark of a qualified professional. In keeping with its tradition of establishing high-quality practice standards, IC&RC developed the professional practice standards for Alcohol & Drug Counselors, which is recognized worldwide as the gold standard for competency in the field.

In its Occupational Outlook Handbook, 2010-11 Edition, the U.S. Department of Labor has named substance abuse and behavioral disorder counselors as one of the fastest growing professions. The report goes on to mention the value of certification: "Becoming certified is voluntary, but having certification may enhance one's job prospects."

# **CREDENTIALING 101**

Credentialing provides standardization to the rapidly growing profession of addiction recovery counseling.

Becoming credentialed demonstrates competency, by having professional expertise and qualifications verified by an independent evaluator. It recognizes achievement of a standard of professional education and experience necessary to provide quality treatment services.

The internationally recognized standards for an Alcohol & Drug Counselor (ADC) are:

#### **EXPERIENCE:**

6,000 hours of supervised work experience specific to the ADC domains. An associate's degree in behavioral science may substitute for 1,000 hours; a bachelor's degree in behavioral science may substitute for 2,000 hours; a master's degree in behavioral science may substitute for 4,000 hours.

#### **EDUCATION:**

270 hours specific to the domains. Six hours must be specific to counselor ethics.

#### SUPERVISION:

300 hours specific to the domains, with a minimum of ten hours in each domain.

#### **EXAMINATION:**

Applicants must pass the IC&RC ADC Examination.

#### CODE OF ETHICS:

Applicants must sign a counselor-specific code of ethics statement or affirmation statement.

#### RECERTIFICATION:

40 hours of continuing education earned every two years.
